Fee for use outside Denmark

Copy of statement*

Generally, using the card to pay for goods and services is free of charge, but merchants outside Denmark are entitled to charge a transaction fee.

Limitations on ATM cash withdrawals

Local withdrawal limits may apply outside Denmark.

Classic

At ATMs bearing the MasterCard logo, you can withdraw a maximum of DKK 3,000 a day, but not more than DKK 15,000 over 30 days.

Gold

At ATMs bearing the MasterCard logo, you can withdraw a maximum of DKK 6,000 a day, but not more than DKK 50,000 over 30 days.

Platinum

At ATMs bearing the MasterCard logo, you can withdraw a maximum of DKK 8,000 a day,but not more than DKK 50,000 over 30 days.

Interest rate

Amounts debited to the card account are free of interest from the debit date to the due date.

Interest and excess interest

If the balance in the card account is not settled by the due date, Danske Bank charges interest and excess interest* from the due date until payment is received. If the account limit is exceeded, Danske Bank charges interest and excess interest* from the date the excess is registered until payment is received, as per Card Conditions.*The interest rate on the account plus an excess interest rate of 6% p.a.
